Notice of Motion 1 - General

Motion- Any team wanting to compete in a Zone tournament must be willing to move onto competing at the Provincial Championships if attending the Zone tournament. If a team is unwilling to travel to Provincials then they should not be participating in the Zone event.

Rationale: We can't have teams competing and possibly causing due harm to another teams chances of attaining a Provincial birth when that team is unwilling to compete at the Provincial level. This year we had the possibility of teams considering playing in zone championships but yet had no willingness to move on and were doing this only to get extra games in. if teams want to get extra games in they should do this throughout their season of play, not at a Provincial qualifying event.

Friendly Amendment:

Motion- Any "basketball" team wanting to compete in a Zone tournament must be willing to move onto competing at the Provincial Championships if attending the Zone tournament. If a team is unwilling to travel to Provincials then they should not be participating in the Zone event.

Notice of Motion 2: Basketball

Motion- The rankings deadline for Basketball will be moved to the last Friday of February. While the rankings are to be released by the following Monday, Appeals by the following Tuesday at 3:30

Rationale: Too many games are midweek the last week and to ensure all information is in this will give an extra two days. I know people want to keep another weekend in for rankings but that is what appeals are for if they are not happy with their seeding.

Rationale: These are filler games that we can save money on if not played and do they really have any value? If teams get a bye, they get the bye to the next round, simple as that based on their years work.

Notice of Motion 4: Basketball

Motion: Remove 3C in Basketball about 3A Schools having the ability to select or nominate officials for zone tournaments. This is not done, as the Basketball commissioner sits with ABOA reps to determine the officials who are qualified for each of the tournaments

Notice of Motion 5A: Volleyball

1A NEASAA Volleyball Playoffs

If each district is represented by at least 1 team and if there's 17 teams or more in the NE zone, the 1A NEASAA Volleyball Championship shall be a 10 team format. Otherwise, the Championshipshall be an 8 teams format.

For a 10 team format, the representation should be as followed:

Host 1 team

District with the most teams 2 teams

1 team per other district 4 teams

Wild card tournament 3 teams

For a 8 teams format, the representation should be as follows:

Host 1 team

District with the most teams 2 teams

1 team per other district 3 teams

Wild card tournament 2 teams

The representative (s) of each district shall be declared 2 Saturday's before the 1A NEASAA Volleyball Championship. The Wild card tournament should occur the weekend prior to the 1A NEASAA Volleyball Championship under a bidding process at the NEASAA fall meeting and under a cost recovery format.

Rationale: November 1st might be too early if zones are held a Nov 20/21 for example.

DEFEATED 5A

Notice of Motion 5B: Volleyball

If 2 districts have the most teams; the district with the best result at the previous zone championship will send 2 teams.

Rationale: Tie-breaking in case of 2 districts having the same numbers of teams.

Friendly amendment:

In the event that there are two districts tied with the most teams, the district with the best result at the previous zone championship will send two teams.

CARRIED 5B

Notice of Motion 5C: Volleyball

Wild card tournament

A. Wild card tournament shall be an 8 teams format.

B. Each district (league) will be eligible to send teams to the 1A NEASAA Wild card tournament in

accordance to the number of schools that have registered volleyball teams with NEASAA.

C. If one to three teams of that district (league) have registered 1A volleyball teams with NEASAA and are not yet qualified to the NEASAA Championship, that district will be eligible to send one

representative team to the NEASAA Wild card tournament.

D. If four or five teams of that district (league) have registered 1A volleyball teams with NEASAA and

are not yet qualified to the NEASAA Championship, that district will be eligible to send two

representative teams to the NEASAA Wild card tournament.

E. If more than five teams of that district (league) have registered 1A volleyball teams with

NEASAA and are not yet qualified for the NEASAA Championship, that district will be eligible

to send three representative teams to the NEASAA Wild card tournament.

Rationale: Old format used for wild card tournament.

Current Policy:

Proposed Motion:

Curling Pool Rotation and Allocation

Pools have been set up on a 5 year rotation to allow the different District qualifiers to meet each

other in pool play. The schedule would continue this rotation after five years.

If one of the Districts does not have an entry for one or all the three categories from Pool B, then

the third District Qualifier from Pool A will drop down to Pool B to balance the pools. This would

allow each pool to have two District Qualifiers.

Wildcard and host positions in a pool may need to be moved to balance Districts that have more than two qualifying teams into zones. For example, if there are three qualifying teams, then the

1st place team and the 3rd place team should be in the same pool, not the 1st place and 2nd place

nor the 2nd place and the 3rd place in the same pool.

If the host is also the District Qualifier, then that team will take the District Qualifier spot in the correct pool and the host position becomes a wildcard for that District. If a District has two berths, they should not be in the same pool. The lowered seeded team should be moved into the other pool by switching wildcards in order to balance pools and eliminate conflicts.

Rationale:

There is no current policy on District Pool allocation for our zone championship. This rotation allows our district schools to face different district schools in round robin play for a 5 year rotation. This also gives the host the information needed to balance pools and eliminate conflicts in the pool allocation.
